Howdy, Friends! We have had a busy start to our schedule this year. We have had three weeks of meetings so far and have been very busy in all three. The first two meetings were in Mississippi. During the first week, in addition to doing nightly revival / evangelistic meetings, I also preached to a men's Bible study in the local jail. There were about forty men in attendance, and we praise God for several professions of faith. We saw souls saved in the church meetings too. The following week we not only preached nightly church meetings, but had the opportunity to present the gospel in a nearby public elementary school. The pastor's wife is the school Librarian. Since we were unable to hold a large assembly, she arranged for us to do four sessions each day with two classes per session explaining what an "Evangelist" is and presenting the Good News of salvation through Christ using puppets, ventriloquism, and music. We were not permitted to "preach" a sermon or to give an invitation, but we were able to clearly present the gospel as we demonstrated the various facets of our ministry. As the pastor's wife commented, "We planted a lot of seed" in those two days.

This week we began the first of three weeks of meetings in Texas. The church has a Christian school so we are doing daily chapels in addition to the nightly revival meetings. We have seen souls saved in both, praise the Lord!
